CROUS

Work part-time while studying!

The professional activity must be taken as secondary to studies, with a limit of an annual working time of 964 hours and a limit work shift of 20 hours per week.

The minimum wage in France (SMIC) is set at 7.72€/hour net salary.

More than 2 months long internship has to be compensated. The net salary can reach 554,40€/month.

Only EU students and non EU students undertaking the OFII procedure have permission to work.

OPEN A BANK ACCOUNT IN FRANCE

A French account is necessary to:

- Apply for the CAF housing allowance
- Buy private insurance
- Sign up for a mobile phone/internet plan

Documents needed to open a bank account:

- Birth certificate and its translated version
- A photocopy of the passport
- The housing contract from CROUS, residence or landlord

French government scholarship

Please note that in France, completing a tax declaration is mandatory. However, it is not necessarily followed by a tax payment.
